## SECTION 4: WRITTEN NOTICE

If the bitch fails to whelp the owner of the bitch must give written notice to the owner of the stud dog at **1, Orchard Croft, Llandrinio, Powys. SY22 6US** Not later than thirty (30) days after the anticipated date of whelping.

A return service will be given to the same stud dog without any additional stud fee only at the next cycle to the same bitch, (the handling fee will be payable again) If the Bitch does not conceive and proper notice is not given by the owner of the bitch, the right to a return stud service is forfeited.

## SECTION 5: TRANSPORTATION

Any expenses of transport and/or shipping both ways will be paid by the Owner of the Bitch unless previously agreed with the stud dog owner.

## SECTION 6: BOARDING

If the bitch is to be maintained at the stud dog owner's property, the owner of the bitch agrees to pay **£00.00** Per Day for board and if grooming is required during the bitches stay the owner of the bitch agrees to pay **£00.00** for the groom.

## SECTION 7: HEALTH AND WELFARE

The stud dog owner has taken every care with the welfare of the stud dog. The stud dog owner confirms to the best of their knowledge the stud dog is both fertile and in good health. The stud dog owner gives no warranties regarding the birth of any puppies arising from the mating(s) covered by this contract. The stud dog has undergone the following health test to screen for the following specific conditions known in the breed.

PRA (cord 1)

MRD, G, GPRA, HC

Any current and/or relevant results for this stud dog are attached to this contract. The stud dog owner confirms that they have seen all the bitch's relevant health test results/certificates.

## SECTION 8: AI

Should Artificial Insemination (AI) be required to accomplish this breeding it may be attempted without the owner of the bitch's permission. Any additional charges for AI will be borne by the owner of the stud dog.

## SECTION 9: PROGENY

The owner of the stud dog agrees to the owners of the bitch keeping puppies for the show ring and/or for breeding purposes whilst the puppy is kept in their sole ownership.

Any breeding resulting from said puppies must have the full consent of the stud dog, in writing. Any stud dog to be used on said puppies must be approved in advance, by the stud dog owners. Said Puppies will be registered without further endorsements.

## SECTION 10: SALE OF PROGENY

The owner of the bitch agrees that any puppies produced from the litter resulting from the breeding of the above two animals will not be sold for show or breeding purposes, save as detailed in section 9 above. All other puppies from the litter resulting from the breeding of the above two animals will be sold as "Pet Only" and will be KC registered with the following endorsements as below (Said Puppies will be eligible for Obedience and Working Trials)

R) Progeny Not eligible for Registration

X) Progeny not eligible for issue of an export pedigree.

## SECTION 11: OBLIGATIONS

The owner of the stud dog is not obligated to sign the application for registration with the Kennel Club of the subject litter until and unless the conditions of payment as well as all other conditions of this contract are fulfilled. The stud dog owner does however undertake that they will sign and complete all relevant documentation to confirm the mating in the event that a litter is produced, and the contract is strictly adhered to.
